Liability Disclosure

- I. Students, parents and legal guardians understand that all types of mountain recreation are hazardous sports and accept and assume the inherent risks of mountain recreation including, but not limited to: changing weather conditions, stumps, forest growth, debris and rocks; loose gravel, dirt, uneven terrain; equipment on trails or slopes; lift towers and other structures and their components; collisions with others and recreational user’s failure to participate within their own individual ability. In using the recreation area, such dangers are recognized and accepted whether they are marked or unmarked. The user realizes that falls and collisions and other accidents do occur and that serious injury or death may result and, therefore, assumes the burden of being in control at all times.
